The alternative to Roberts Rules of Order is parliamentary procedure, which is still used in some countries. In parliamentary procedure, all discussion on an issue must be conducted in "order" to proceed. In most meetings, the majority of board members (except for the chairman) will be required to speak first before proceeding. If a board member has an objection to what another member has just said, he or she must have the opportunity to be heard prior to the board "seconding" the objection by raising the proper number of "nays." Roberts Rules of Order and parliamentary procedure have many of the same rules, but will sometimes conflict with each other. If all board members are familiar with the book, they may be more comfortable with the Roberts Rules methods since they are both familiar with the material, but for a quick and reliable way to conduct business, parliamentary procedure is a quick and relatively painless way to run a meeting. However, parliamentary procedure will also require a new set of board members to become comfortable with new forms of debate and order, as well as handling procedural questions. roberts rules of order's recommendation is to allow for up to three minutes for each speaker to be heard before inviting questions. the objective of this recommendation is to allow participants to present their points of view in a thoughtful manner without being interrupted. the length of a speaker's time should be limited to the most pressing items that need to be addressed. a major challenge that many people face when they first begin to chair a meeting is to determine the appropriate order for items to be addressed. by adopting a specific order of items, the chairperson ensures that members of the group do not fall behind, because they are waiting for others to finish. some meetings require a specific time for each item to be addressed. other meetings have items with fixed deadlines, such as the initial planning session for each project. the different types of meetings and orders are outlined in the roberts rules of order's chapter on the order of business. in general, a meeting is considered formal if it is scheduled for an hour or more. a meeting with a set agenda is considered most formal. a meeting that is not scheduled for an hour is considered informal. roberts rules of order's recommendation of three minutes for each speaker to be heard before inviting questions is to allow for each person's opportunity to speak. if a person is speaking for a longer period of time than allowed, the chair should interrupt that person's speech and invite questions. if a person is speaking for a shorter period of time than allowed, the chair should intervene by asking the person to speak longer. 5ec8ef588b
